Job description

We are seeking an experienced and strategic **Head of Investment Programmes** to work across the Firstport Group, overseeing the design, delivery, and performance of our current and future repayable finance programmes.

This is a senior leadership role and a key member of the **Firstport Leadership Team**, responsible for ensuring our investment activity delivers strong performance, sound governance, and measurable impact. Due to the nature of the Firstport Group structure, this role acts as the primary link between Firstport and Firstfund. In practice, this means leading the delivery of the Firstfund strategy and maintaining a close working relationship with the Firstport Board through regular engagement, collaboration and reporting.

The successful candidate will lead both the **strategic direction** and **operational management** of our investment programmes, ensuring these are delivered on time, on budget, and to a high standard of quality.

They will take a leading role in ensuring operational and financial processes, fund governance and risk frameworks are robust and effective, alongside overseeing all aspects of investment readiness support, pipeline development, impact investment and portfolio management. This will all be achieved through **building**, **leading and supporting a high-performing**Investment Team (currently a team of five, including four direct reports).

Current investment programmes include:

- **LaunchMe**, an investment readiness programme that supports social enterprises to secure social investment.
- **Step Up**, a 0% interest loan for social enterprises looking to replicate or grow revenue–generating activities.
- **The Catalyst Fund**, an innovative, revenue-based fund for ambitious Scottish enterprises unable to secure other social investment.

This is a particularly exciting time for the **Catalyst Fund**, our largest investment programme. We are entering the final stages of implementing a new strategy, rolling out additional strands in partnership with key collaborators. Key duties & responsibilities

Strategic

- Provide support and guidance on the Investment Programmes and to the Investment Team to ensure the success of current activity and funds
- Engage in networking and relationship-building activities with coinvestors, impact funds, and other stakeholders in the social investment ecosystem
- Position Firstport's investment programmes and funds as important contributors to the Scottish ecosystem
- Play a key role in business development, seeking and curating opportunities for Firstport to develop its role supporting start-up social enterprises within the social investment ecosystem
- Provide strategic leadership across the Firstport Group in relation to social investment and in partnership with the Group CEO, the Leadership Team and other key stakeholders
- Key point of contact for the Scottish Government, with responsibility for reporting
- Present financial performance, investment updates and operational reports to the Board and key investors, including the Scottish Government
- Represent Firstport externally at committees, fund boards, and strategic sector events.

Management

- Lead, support, and develop the Investment Team, fostering a culture of high performance through clear roles and responsibilities and a culture of collaboration and learning
- Provide clear direction, guidance, and support to direct reports
- Build team capability in fund management, due diligence, and social investment practices
- Support team development by attending and supporting Investment
 Team members in relevant Investment Committee and Firstfund board
 meetings as appropriate
- In conjunction with the CEO and other members of the team, attend meetings and events to represent the organisation.

Operations

- Lead the delivery of existing (and new) investment programmes and funds, ensuring effective and efficient fund management systems, processes, and compliance frameworks that meet the needs of social enterprises
- Implement and oversee robust financial controls and best practice in portfolio monitoring, risk management and reporting
- Support pipeline development, deal origination activities and screening alongside the Investment Team and with pipeline partners
- Oversee, and contribute where required, to all aspects of deal execution, including market and financial due diligence, structuring, preparation of investment committee reports and papers
- Primary lead and point of contact for the Investment Committee, including recruitment and management
- Oversee investment committee processes and support Investment
 Team members in the Investment Committee
- Oversee portfolio monitoring and input into support planning for investee organisations
- Manage all aspects of financial operations, including cash flow, management accounts, audit and statutory reporting (in partnership with Finance Officer, CEO and external accountants/auditors)
- Lead annual budgeting, forecasting, and long-term financial planning processes

• Work collaboratively with other teams (Comms, Programmes, Impact) to ensure the programmes reach their intended audiences and that processes are in place to report on their impact.
